Carrie Liu Currier '96 always wanted to attend the University of Michigan. Growing up in lowa, she cheered for the Wolverines alongside her father, a huge Michigan football fan who watched every game on television. The day Carrie got into Michigan was the best day of her life.

As a first-generation college student, she didn't really know what to expect at the university. In true LSA fashion, she enrolled in a sampling of seemingly random classes her first semester, including, on a whim, an 8 a.m. international politics course taught by Ted Hopf.

"I was interested in politics, but not really that interested in politics. It just sounded like an interesting class and it was open," Carrie says.

That class turned out to be one of the most important choices she would make at Michigan, leading to her decision to major in political science. Carrie followed up with classes in Chinese politics.

"That first class in international politics just changed my outlook. It was a little bit scary. It was completely challenging. It was everything that I had been afraid college would be like—and also everything that I hoped it would be like," Carrie reflects.

She went on to earn an M.A. and Ph.D. in Political Science, Comparative Politics and International Relations from the University of Arizona and is now the Chair of the Political Science Department and a professor of Chinese politics at Texas Christian University.

But her bond with the University of Michigan, where her passion for international politics was sparked, remains strong.

Fund at LSA for undergraduate students in political science or Asian studies.

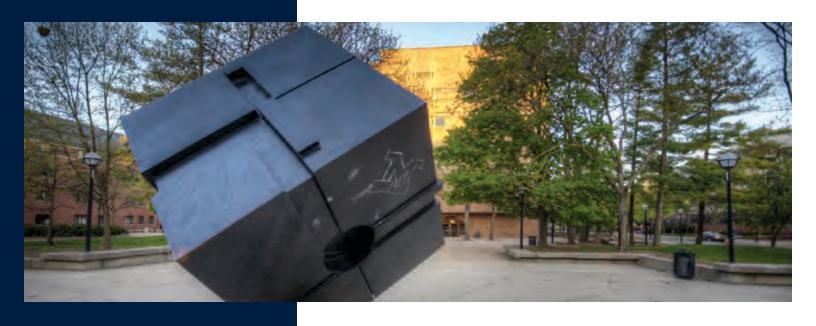
She was inspired to make a planned gift now, in part, by a friend who had recently made a gift to her own Big Ten alma mater.

There are two ways you can use your IRA to support U-M, allowing you to make a blended gift with just one asset. Here's how:

- 1. A gift for today. If you are 70½ or older, you can transfer any amount up to \$100,000 directly from your IRA to a nonprofit like U-M. This gift doesn't generate income, so you benefit even if you don't itemize on your taxes.
- **2. A gift for tomorrow.** You can also name U-M as the beneficiary of your IRA. After your lifetime, the funds will pass to U-M, extending your impact and making a difference for future students.
